



#### **PATROL DIVISION**

The Patrol Division is under the command of Director Scott Beaver and is comprised of Road Patrol, Special Events and Youth Services.

#### ROAD PATROL

St. Johns County is divided into three geographical regions that run east to west from the St. Johns River to the Atlantic Ocean and north to south with boundaries strategically designed to optimize response times for calls for service.

#### **NORTH REGION**

#### SPECIAL EVENTS



Tres Edenfield

Special Events is comprised of Emergency Management and Traffic / DUI Units. Public Service Assistants (PSA), and Beach Services.

#### EMERGENCY PREPAREDNESS / **MANAGEMENT UNIT**

This Unit provides an organized and disciplined preparedness and response to unusual, prolonged incidents that would over-tax normal resources of the agency.



#### TRAFFIC UNIT

The primary responsibility of the Traffic/ DUI Enforcement Units is to investigate crashes in the county to include (THI) Traffic Homicide Investigation and traffic enforcement.



#### **PUBLIC SERVICE** ASSISTANTS (PSA)

Public Service Assistants (PSA) are responsible for traffic control for all public schools, minor traffic crashes, illegal parking enforcement, traffic control during crashes and special events. They also assist Road Patrol with reports on delayed crimes with no suspect.



#### **BEACH SERVICES**

Beach Services Deputies are responsible for enforcing state law, county ordinance violations and assuring beach wildlife is protected on the county's 42 miles of beach stretching from Marineland to Ponte Vedra Beach



#### YOUTH SERVICES



The Youth Services Unit is comprised of the Police Athletic League (PAL), Youth Resource Deputies, School Crossing Guards, a Juvenile Civil Citation Coordinator, and the Explorer Program.

#### POLICE ATHLETIC LEAGUE (PAL)

The Police Athletic League is a non-profit division of the St. Johns County Sheriff's Office which serves over 2,500 children annually through various sports programs and summer camps.



#### EXPLORER PROGRAM

The SJSO Explorer Post 911 is an orientation program for young people considering a career in criminal justice. The mission of the Post is to offer young adults ages 12-21 a behind the scenes look at the criminal justice field through training, practical exercises and community activities.

#### YOUTH RESOURCES

School safety and protection are the sole responsibility of those who service in the Youth Resource Deputy Unit. Youth Resource Deputies and Supervisors protect the county's 43 public schools. Not only does each deputy serve as the school's "guardian", the Youth Resource Deputy (YRD) provides prevention programs, assists with drills, tends to law enforcement functions, travels with students and staff out of the county on trips, sponsors school clubs and have been known to coach a school sport.

#### JUVENILE CIVIL CITATION

The Juvenile Civil Citation (JCC) Coordinator is a YRD who is primarily responsible for youth who have received a JCC. A JCC is a mechanism for first time misdemeanants to enter a structured community diversion program with no arrest record upon successful completion. The YRD overlooks, administers and monitors all aspects related to the recipient from when the juvenile is cited to the completion of any required programs.

#### SCHOOL CROSSING GUARDS

The Youth Services Unit includes 67 School Crossing Guards who are assigned to work 98 school posts at 20 schools. Additionally, the unit coordinates several community events such as Bicycle / Pedestrian / Stranger Danger training for second and third grade students, bicycle helmet fittings and donations.

#### **OPERATIONS DIVISION**

#### WITH TRAINING AND EXPERTISE, WE ARE HERE TO SERVE

The Operations Division is under the command of Director Russ Martin. This division consists of over 100 sworn and civilian personnel with great varying areas of responsibilities.

#### **OPERATIONS**



In 2022, the Operations Division law enforcement functions include Training Unit, Aviation Unit, Marine Unit, Mounted Agricultural Unit, Unit. Recruitment, and all St. Johns County Sheriff's

Office Special Teams. These diverse fields are managed by four lieutenants, responsible for oversight, each management and leadership of their respective sections.



Special Operations consists of nine teams, each with specialized equipment and personnel specifically trained to handle any emergency. These teams consist of: SWAT, SWAT Support, E.O.D. (Bomb), C.N.T. (Crisis Negotiations Team), C.L.E.T. (Clan Lab Enforcement Team), Field Force, Dive Team, K-9 Team, Safe Trak and Mobile Command/ High Water Rescue Teams.































#### **AIR AND MARINE OPERATIONS**

Air and Marine Operations is responsible for the Aviation Unit, Drone Team, Marine Unit, Mounted Unit, and Agricultural Crimes Unit. This diverse group of full time personnel handles all calls from the air, on water, or in wooded or sparsely populated areas. Their mission is to support all agency functions and provide resources to Patrol and Investigative Units that further the capabilities of these groups.







#### **RECRUITING AND F.T.E.P**

and Field Training and Recruiting Program (F.T.E.P.) Evaluation responsible for the oversight of all recruiting efforts of the St. Johns County Sheriff's Office, as well as all training requirements of newly hired deputies. This training includes classroom and tactical components and includes mandatory and advanced training methods.

#### **TRAINING**

Training is responsible for all aspects of training for sworn personnel. This training includes leadership, management, and operational and tactical training. The SJSO Training Unit manages multiple training components each day and many hundreds of hours of training annually to our sworn members.

#### COMMUNICATIONS

The Communications Unit is comprised of Communications Training and Public Safety Telecommunicators (PSTs) who answer administrative calls, 911 calls, and dispatch calls for service, 24 hours a day, 7

days a week to all areas of St. Johns County. The Communications Center is the hub for all calls for service in St. Johns County for the St. Johns County Sheriff's Office, St. Augustine Police Department, St. Augustine Beach Police Department, and the National Park Service. Additionally, E-911/GIS, Switchboard, and Validations provide excellent service to the visitors and citizens of St. Johns County. From the training of our deputies and PSTs, to deploying of our specialty teams, and providing the technology needed to ensure emergency 911 calls are received and disseminated in moments of crisis, this unit is the lifeblood of our agency and the individuals who make up this unit are without a doubt our "Heroes in Headsets."

#### COMMUNICATIONS SUPPORT

Communications Support Unit encompasses varying responsibilities to include our Validations, Quality Assurance, Communications Training, and the Switchboard. Our quality assurance program is a proactive step to ensure we achieve high standards in our handling of 911 calls. In 2022, over 3,000 random quality assurance reviews were completed. Additionally, our Validations team met with representatives from FDLE and FBI, and successfully completed multiple audits ensuring the agency's compliance with governing polices.

#### E-911 / GIS

E-911/GIS staff works with citizens and county agencies to ensure the addressing of St Johns County is accurate and up-todate. They also provide the technology needed to ensure a caller can be located when a call is placed. Since 2020, our E911/GIS area has been awarded over \$1.7 million in grant monies to support the county's 911 system.





#### **CRIMINAL INVESTIGATIONS** DIVISION

#### FIGHTING CRIME WITH TALENT AND **TECHNOLOGY**

The Criminal Investigations Division (CID) is under the command of Director Howard "Skip" Cole. The Division is divided into two distinct areas under the purview of Captains Ryan Smith and Bill Werle. Captain Smith is responsible for the Real-Time

Intelligence Center, Property Crimes, Special Investigations (Narcotics), and Internal Affairs. Captain Werle is responsible for Major Crimes, Special Victims, Digital Forensics, Internet Crimes Against Children (ICAC), and Forensics. The Criminal Investigations Division is staffed with approximately 90 sworn and civilian members that comprise a diverse workforce of subject matter experts uniquely qualified and equipped to respond to, and investigate, any type of criminal case, regardless of the severity of the crime. Our agency mission is to "Serve with Excellence" which is our guiding principal as we analyze all of our cases with a sense of urgency and focused detail to ensure justice and closure for all crime victims in St. Johns County.

#### INTELLIGENCE UNIT / REAL TIME INTELLIGENCE CENTER (RTIC)



The Intelligence Unit and Time Real Intelligence Center (RTIC) is comprised of Intelligence Analysts who play a dual yet vital role. They carry a caseload with specialized investigative units and help them solve

cases with technology and analytics. Simultaneously, they assist Patrol Deputies in real-time by providing support through






technological resources. This additional information is then utilized to further investigate cases, reduce crime, and/or save lives. Intelligence Analysts have various tools at their disposal, including, but not limited to: License Plate Readers, surveillance cameras, aggregation software, data mining software, and other advanced technologies.


#### DIGITAL FORENSICS



The Digital Forensics Unit is a team of highly trained detectives who examine electronic storage devices including cell phones, computers, vehicle infotainment systems and much more. Their work is

essential in solving a myriad of cases including murder and child exploitation investigations. The examiners must follow strict guidelines and procedures to ensure that all evidence is properly collected, stored, and analyzed. This includes following chain of custody protocols to ensure that evidence is not tampered with, or altered, in any way. The Digital Forensic Unit uses the latest advanced training, equipment and software, in a state of the art lab, to maximize their capabilities. Many local, state and federal law enforcement partners request our Digital Forensic Detectives to assist and examine their cases. In 2022, the Unit examined over 96 terabytes of data. To put this in perspective, the Library of Congress is approximately 10 terabytes of data if you digitized all of their library books. In the near future, all crimes will likely be intertwined with a digital forensic nexus. And that is why our detectives believe "There is nothing concealed that will not be made known".









#### **CORRECTIONS DIVISION**

The Corrections Division is under the command of Director Jason Caban. Corrections is responsible for the care and custody of all inmates by ensuring they are appropriately booked, properly housed, have access to self-improvement programs, and their medical needs are satisfied. Director Caban is also in charge of our Civil/Warrants Unit, which processes and serves arrest warrants, eviction notices, injunctions, etc. In addition, he oversees the Bailiff's Unit, ensuring that they provide proper security for the Courthouse and Board of County

Commissioners building. Director Caban is assigned three captains to assist him in achieving divisional objectives.

#### JAIL OPERATIONS

This position functions as a liaison between other Bureaus, in addition to being responsible for all jail operations taking place inside the Main Unit and the Community Work Release Center (CWRC). These

operations fulfill a multiplicity of functions to include supervising and coordinating daily activities within each facility for both staff and inmates, these duties include, but not limited to; staffing of shifts, admissions and releases, recreation, visitation, serving meals, headcounts, medical visits, laundry exchange, programs, responding emergency situations and inspections of housing areas for sanitation and security concerns.



#### SUPPORT SERVICES

The Corrections Support Services Bureau is under the direction of a Corrections Captain. This position is responsible for Programs, Re-Entry. Professional Development, Classifications, Inmate

Communications, Accreditation, and Inmate Work Squad Units.

#### PROGRAMS AND RE-ENTRY

Inmates are provided opportunities for self-improvement and re-entry services through a vast array of programs including religious, substance abuse, mental health and educational programs by a team of professionals dedicated to making people a little better when they leave than they were when they arrived here. The team assists with providing job skills training, job placement, providing housing and obtaining documents vital to a successful re-entry into our community.

## SPOTLIGHT: RE-ENTRY

In 2022, the St. Johns County Sheriff's Office began renovating a building tethered to the main unit of the jail for the SJSO Re-Entry Center. Our Re-Entry team is taking this program to new heights, and with this building, are creating new and innovative methods to include: Career Fairs, Housing Fairs, DMV Identification Cards and/or Driver License, and a Computer Lab for GED testing, job applications, and many other programs which will be offered here in the jail.

**Reunification** — Helping homeless individuals with no local support reconnect with family or friends elsewhere

Transitional Housing — Resource partners which we rely on to assist with housing for those who qualify

**Business Partners** — Employers across the county have hired released inmates to fill much-needed job vacancies

**Veteran Resources** — Provide residential treatment with therapeutic support, mental health, and service dogs for individuals who served in the military and suffer from PTSD, depression, substance abuse, and homelessness

K9s for Warriors — Partnership with the well-renowned K9s for Warriors with a program which will teach inmates a valuable trade through three months of training service dogs which benefits the incarcerated, veterans, and rescue dogs.

Our recidivism rate went from 25% to 16% in just over a year. We are making a difference, and with everyone's help, we can continue to improve our community and people's lives.



#### **PROFESSIONAL DEVELOPMENT**

Responsible for conducting and coordinating all new hire training, annual in-service training, (IST) shift training, as well as managing special teams (Security Response Team, Rifle Team and Security Threat Intelligence Team) and an Intelligence Detective. The Intelligence detective collects, analyzes and disperses data related to crimes and other statistical data relevant to the agency in addition to communicating actionable intelligence in real time, filing charges for crimes committed within the jail, conducting investigations and following up on cases as they progress through the criminal justice system.

#### INMATE COMMUNICATIONS

Responsible for contracting and overseeing all inmate communications including visitation, mail services, inmate tablets and phones. The unit also works closely with our intelligence unit as well as responds to public records requests.

#### **ACCREDITATION**

The Accreditation Sergeant is responsible for compiling and maintaining all records required to verify our adherence to Florida Statutes, Florida Administrative Code, Florida Corrections Accreditation Commission (FCAC) and Florida Model Jail Standards (FMJS) as well as coordinating and conducting inspections.

#### **INMATE WORK SQUADS**

These squads consist of male inmates sentenced to the county jail for 364 days or less. Inmates are allowed to participate in the program provided they meet the criteria.

#### **COURT SERVICES**

The Corrections Support Services Bureau is under the direction of a Corrections Captain. This position is responsible for Admissions and Releases, Bailiffs, Classifications, Court Services, Criminal Process,

and the Transportation Unit.

#### **ADMISSIONS AND RELEASES**

Admissions and Releases (Booking) is responsible for admissions, arrests, intakes and releases of all adults and juveniles into the St. Johns County Detention Center.

#### **BAILIFFS**

Bailiffs provide security for the St. Johns County Courthouse, Tax Collectors Office and other government buildings located within the Judicial Complex.

#### **CLASSIFICATION**

Classifications Deputies interview and house inmates using current arrest information, criminal history, behavior, medical needs and past incarcerations.

#### **COURT SERVICES**

Court Services is responsible to process all criminal and civil court orders. Court Services executes orders of the courts in reference to property levying, execution of writs, receives and processes capias and arrest orders.

#### **CRIMINAL PROCESS**

Criminal Process Unit updates criminal and civil court proceedings for incarcerated adults and juveniles.

#### **TRANSPORTATION**

Transportation is responsible for the movement and transfer of inmates to court, external medical appointments and transfers to outside facilities.

## **SPOTLIGHT:** REACCREDITATION

On June 15, 2022, the St. Johns County Corrections Division was awarded reaccreditation by the Florida Corrections Accreditation Commission (FCAC) with the distinction of "Excelsior" status for the second time.



The St. Johns County Corrections Division received its initial accreditation by FCAC on June 22, 2004. The accreditation process is an essential element in the furtherance of professionalism within our agency. The standards are prevalent in our daily activities and serve as a benchmark for achieving the highest standards of proficiency. A team of FCAC assessors conducted an onsite assessment and examined all areas and processes within the Corrections Division, including: admissions (booking),

classification, housing, sanitation, food service, personnel issues, fiscal activities, security, training, releases, and medical. Once completed, the assessment team unanimously recommended reaccreditation with Excelsior status. Excelsion status recognizes, and is limited to, agencies which have earned five continuous reaccreditations without any conditions.

#### EMPLOYMENT TEAM

The Employment Team manages all applicants


and the hiring process for the agency. In 2022, they processed a total of 1,615 applicants for 167 open positions. They also implemented a new hiring process, which improved the time from application to new hire orientation. In collaboration with the Training Unit, they developed a streamlined process for applicants to submit documents and fingerprints, complete pre-polygraph questionnaire and pre-employment testing all in one day.

In 2022, the Employment Team added a full time polygraph examiner. 257 applicant polygraphs were conducted. Additionally, the St. Johns County Sheriff's Office launched a partnership with a team of psychologists specializing in the care of first responders, which reduced the turnaround time for testing results.

#### **PERSONNEL TEAM**

The Personnel Team is tasked with rigorously maintaining personnel files, contact information, position control, payroll, and performance management. The Personnel Team hosts quarterly ceremonies to welcome new members and their families to the St. Johns County Sheriff's Office. They are also responsible for the agency's promotional process which resulted in 28 promotions for 2022.

#### **RISK MANAGEMENT**

The Risk Team is responsible for managing programs which keep the members of the St. Johns County Sheriff's Office safe, healthy and financially fit. The Risk staff members manage the following programs: health, dental, prescription and vision insurance plans, Florida State Retirement System (FRS) pension and investment plans, flexible spending accounts, employee assistance programs, workers' compensation, Family Medical Leave, Affordable Care Act, Cobra administration, provider billing, wellness programs, deferred compensation plans, and liability contracts.

#### SHIELD PROGRAM

Mental Health Professionals contracted by the agency provide 24 hour access to individual consultation and support, attend unit briefings, psychoeducational workshops, team building, and unitspecific retreats. Shield's educational classes address relevant occupational, operational, and familial issues.


This team is comprised of members who manage the Budget, Payroll, and Munis Workflow. Our Budget team assists with creating and managing a \$110 million budget. Our Payroll section ensures our 969 employees

are paid on a bi-weekly basis. The Munis Workflow Specialist works to ensure employees are in the system on proper shifts with the proper controls in place.

#### **BUDGET / PAYROLL**

This position is responsible for the coordination, development, implementation and fiduciary responsibility of the agency's budget.

#### **ACCOUNTING**

Our Accounting section manages grants, travel, accounts payable, and capital assets. Additionally, this area works with outside auditors to make sure we are Generally Accepted Accounting Principles (GAAP) compliant regarding policies and procedures. Our Grants Specialist manages various grants awarded to our agency throughout the fiscal year. The Travel Specialist arranges travel and outside training for all employees including class registrations, hotels, airfare, and per diem. Our Accounts Payable team codes and pays all invoices and purchase cards as well as maintains our Purchase Order system. The Capital Assets team helps to inventory and reconciles 6,891 capital assets owned by our agency.

#### **PROCUREMENT**

The Procurement Team has recently moved from a 1,200 square foot warehouse into a 4,000 square foot warehouse enabling them to more efficiently manage all aspects of inventory including ordering, storage, receiving, shipping and issuing. This team is also in charge of the agency's annual inventory. Vending machines have been installed in our field offices allowing deputies to pick up supplies within their work area instead of having to come back to the central office.

## SPOTLIGHT: INCIDENT-BASED REPORTING SYSTEM

In 2022, The St. Johns County Sheriff's Office began implementing a new Incident-Based Reporting System that allows the agency to collect more comprehensive crime data. The transition is part of a major initiative nationwide to improve crime data collection by law enforcement, which is called NIBRS, or the National Incident-Based Reporting system. The Federal Bureau of Investigation oversees the collection of NIBRS data. Florida's version is called FIBRS, or the Florida Incident-Based Reporting System. The Florida Department of Law Enforcement will oversee the collection of FIBRS Data.

Previously SJSO and other law enforcement agencies throughout Florida used Summary-Based Reporting to collect and report crime data for the purpose of Uniform Crime Reporting data collection (UCR). The key difference is that Summary-Based Reporting only counts the most serious crime of a particular incident, while Incident-Based Reporting counts all crimes committed during an incident. This detailed data will aid the Sheriff's Office in developing a more complete and transparent overview of various crime types occurring in St. Johns County, in addition to helping to expedite identifying crime trends.

The new system will capture details on each single crime incident, as well as on separate offenses within the same incident. This new method of data collection will have a cumulative effect on combating crime issues and solving quality-

of-life issues. Due to this change, crime statistics will initially appear to show increased numbers; however, this does not mean the crime rate is rising.
